With Reference to Section I, Instructions to Bidders, **Clause 8 “Amendments of Bidding Documents”**, the Employer, Albania Road Authority (ARA) is amending Bidding Documents by issuance of this addendum as follows:

Amendment Number 1:

Section II: Bid Data Sheet:

- 1. ITB 14.7:** The following clause is added:

The Value Added Tax (VAT) at the rate of 20%(required as per Albanian Tax law for civil works) should be included separately by the bidder in its bid.In this regard bidders

should include under the tables Payment schedules A (Rehabilitation Works), B (Improvement Works), C (Network Performance Services) and the Bill of Quantity D (Emergency Works), and respectively for each of four lots A, B, C and D after the last line by adding the following two additional lines, at the end of each table:

- (i) VAT on the total price at the rate of 20%;
- (ii) Grand Total including VAT 20%.

2. ITB 15.1: The Currency of the bid shall be as follows:

Delete “**Albanian Leke**” and Substitute “**Euro**”.

3. ITB 19.1: A bid security shall be required

Delete “**34,000 Euro**” and Substitute “**340,000 Euro**”.
